RG 146 Superannuation Refresher

A quick, convenient way to keep up to date with the latest changes to the super industry and help maintain your RG 146 compliance in super.

Course overview

Continuing training is essential for advisers and fund staff providing general advice to maintain their competence with ASIC's Regulatory Guide 146 (RG 146). This is particularly important in superannuation due to its rapidly changing industry and regulatory requirements. ASFA's RG 146 Superannuation Refresher has been developed to assist in meeting these critical compliance requirements by re-capping the key points from RG 146 and providing a comprehensive update of any changes to legislation, regulatory policies and standards, and economic and financial developments that impact the RG 146 superannuation specialist knowledge areas.

Offered as a choice of e-learning or virtual workshop, the program can be accessed any time on any device, allowing you to work at your own pace and in your own time. ASFA's RG 146 Superannuation course is known as the benchmark course for acquiring the skills and knowledge for anyone working in the superannuation industry, not only for those providing advice, and this refresher course is essential in ensuring the knowledge and skills gained from that course remain current and up to date.

Leveraging the industry expertise of the ASFA policy & research team, ASFA's RG 146 Superannuation Refresher is updated regularly to ensure currency of content and it is recommended that people complete the program once every 2 years.

What's covered in the course?

The RG 146 Superannuation Refresher re-caps the key points from RG 146 Superannuation and provides an update of any new legislation or industry changes. By completing this course, it is expected that learners will get an update to any changes that impact the RG 146 superannuation specialist knowledge areas:

- Operation and management of the superannuation industry
- Taxation
- Legal environment—disclosure and compliance.

Structure

The RG 146 Superannuation Refresher consists of 1 x e-learning module, comprehensive additional reading resources and a 30-question multiple choice exam. The e-learning module can be accessed anywhere at any time on any device that has internet access, so you can study in the office, at home, or while travelling to and from work. The comprehensive additional reading section contains fact sheets, reports, and reference material which are highly recommended reading for anyone wanting to keep up to date with changes within the superannuation industry.

Course entry requirements

There are no pre-requisites or entry requirements for RG 146 Superannuation Refresher. However, the program has been designed for people who are already RG 146 compliant.

Delivery modes

Flexible Online Learning

The RG 146 Superannuation Refresher course is delivered completely online in an interactive e-learning format that can be accessed on any device that has internet access – for study in the office, at home, or while travelling to and from work.

Virtual workshop

There is also a 3 hour facilitated virtual workshop option for those learners who prefer to engage with ASFA's expert trainers and network with industry peers. This is delivered in a blended format with a combination of virtual workshop and interactive e-learning module formats.

Both online and virtual workshop learners will receive comprehensive additional reading resources, factsheets, and reference material.

Course Duration

Learners have three months to complete the RG 146 Superannuation Refresher course and should work at their own pace.

Time commitment

The estimated time commitment is around four hours (including self-paced study time). Learners only need to set aside 20 minutes a week to complete the entire course within the overall three month course duration.

Assessment

Learners need to achieve a pass mark of 80 per cent or greater in the 30-question online multiple-choice open book quiz to successfully complete the course.

The online quiz can be accessed at any time throughout the course, but it is recommended learners work their way through the e-learning module and additional reading before attempting the quiz.

Completion

Upon successful completion of ASFA's RG 146 Superannuation Refresher learners will receive an ASFA Certificate of Completion and digital badge.

Compliance with ASIC Regulatory Guide 146 (RG 146)

In order to meet the ASIC Regulatory Guide 146 continuing training obligations, "licensees need to establish policies and procedures on continuing training that will address how they and their advisers will:

- (a) maintain knowledge and skills that are appropriate for their activities and responsibilities, and are consistent with the training standards;
- (b) update their knowledge and skills, especially in areas where there is continual change (e.g. legislation, regulatory policies and standards, economic and financial developments, new products and new market practices); and (c) develop new knowledge and skills to assist with their current role or roles contemplated in the near future.

The RG 146 Superannuation Refresher course has been developed by ASFA to support individuals in meeting these continuing training requirements and ensure their superannuation knowledge remains up to date.

Continuing Professional Development (CPD)

Learners receive four Continuing Professional Development (CPD) points upon the successful completion of the RG 146 Superannuation Refresher course.

Continuing Professional Development (CPD) is a career-long approach to planning, maintaining and developing knowledge and skills needed to succeed in the competitive business world.
